General Guidelines:

- Applications must be fully completed (typed or handwritten) and accompanied by the required documents.
- Communication: An email will be sent upon receiving the application, but it is the applicant's responsibility to ensure all other requested documents are submitted.

For High School Seniors:

1. Submit a **High School Transcript** Request Form.
2. Complete all pages of the application.
3. Postmark the application by **March 2nd, 2026**.

For College Students:

1. Submit a **High School Transcript**, even if previously applied.
2. Submit a current **official college transcript** (grade reports are not acceptable).
3. Include transcripts from **all colleges attended**.
4. Postmark the application by **March 2nd, 2026**.
